


SHISHU NILOY FOUNDATION (SNF)

# **Non-formal Primary Education**

SNF pre-primary schools provide children with a foundational skills base in literacy, reading and mathematics, and seek to promote children's emotional and physical development for success in primary school. A massive number of the four to five-year group are still out of school in Bangladesh even every government school in Bangladesh have a pre-primary school affiliated with it. According to current scenario of our country, urban children, especially those with educated parents and from more privileged socio-economic backgrounds, are more likely to have access to pre-school education but it is not so much in rural areas even now various government and non-government agent has taken special initiative to promote this activity.

SNF started non-formal primary education with the financial assistance of BRAC Bangladesh since 1998. Up to 4 years in this project the students concerned study up to class five. Through the project the students are increasing their potential progressive, harmonious development through their own cultural programs incorporating games & sports, sit and draw picture competition, dance, recitation of poems and dramas. SNF pre-primary schools provide children with a foundational skills base in literacy, reading and mathematics, and seek to promote children's emotional and physical development for success in primary school. Teachers are women from the local community. The studentteacher ratio is kept low at around 1 teacher for every 25-30 students.





The main objective of this center is to ensure management and participation of the community people. Continue education centers conduction remains progressive by their direct cooperation and assistance. The disadvantaged people are ensured fundamental education and sustainable socioeconomic development.

# **Key features**

- The one-teacher school is operated by the same teacher for the same cohort of children for a period of four years and delivers lessons in all subjects
- The school hours are flexible and fixed according to needs little or no homework as most of their parents are not capable of assisting them

# Continuation of Domestic Violence Prevention & Intervention (DVPI)

With the donation from the MISEREOR Germany the project named Continuation of Domestic Violence Prevention & Intervention (DVPI) was implemented successfully from May 2014.

# **Development Goal**

Over the period of three years domestic violence of Vulnerable Women (VW) and Adolescents Girls (AGs) has been reduced in Magura (05 unions) and Jhenadah sadar (05 unions) Upazilas through awareness and capacity building interventions.



# **Objective**

- All the Members of the 10 Unions are helping the victims of the trial through training and they are now known about law and women rights.
- The reputation of the organization has increased through the project implemented at the grassroots and district administration level. Efficient and active manpower has been created and they have ability of project and financial report writing. Organization achieved skill to carry out a large scale project with the replication of the project.
- Through the Project implementation & coordination, District Legal Aid committee giving the litigation support without cost.

# **Key Features**

Shishu Niloy Foundation has been implemented the project through major activities with directly linked with government departments such as; awareness on early marriage, orientation for school students, victims refer for legal support to

- District Legal Aid Committee and also members of those committee, victims refer for primary treatment to OCC-Sadar hospital, participation of the mass people of communities show drama and cultural activities.
- All the Union Parishad's Members and selective beneficiaries' have received training from the project. Thus, a good relation with community people, the awareness of women's violence resistance has increased and also in the areas local community and local leaders help to protect women's domestic violence.
- SNF has established an effective working relation with the different departments of government offices for the prevention of child marriages and domestic violence through the project.
- Ward committee members are acted their role and responsibilities and ensure their involvement with all type of activities of the project.
- The targeted people know the OCC (One stop Crisis Centre) for free medical service and get better services from this department through the project.

SNF awarded for 'Special contribution of preventing Child Marriage 2017' at two Unions at Magura district from the respective District Commissioner/ District administration of Magura. And two Unions of Magura Upazila have declared early marriage free Union through Shishu Niloy Foundation's with the support of community people, UP members, UNO and Government officials.

SNF promote renewable programs to reach among the mass people how to save the environment through waste management and convert the waste in to energy. Bio-gas Plant is the total solution for keeping the Environment Clean, elimination of air, water or soil pollution and improves Public Health, help National Grid with additional amount of electricity from biogas, and offer cooking gas or CNG where natural gas is not available. SNF is well concerned about the right design, safety and sustainability while setting up a plant by any Member and ensure highest yield of production. Safety is very important for the customer as well as for the Financing Organization.

#### Goal

To ensure ultra clean, natural and a sustainable source of energy and increase the working hour after dusk to the non grid areas of SNF's working area. That provides non polluting lighting services.

- To encourage the preferential use of renewable energy in SNF's working area.
- To debate the best technical and sustainable options for increasing renewable energy and energy efficiency.
- Facilitate Research and Development in renewable energy and energy efficiency
- Disseminate information on renewable energy and energy efficiency

SNF upholds the essence of the context of this project; most of the rural people depend on biomass, crop residues, plant debris, animal dung and wood for fuel creating deforestation, flood, soil erosion etc. Women and children, on whom the burden of collecting fuel falls, suffer the most.

SNF began Solar Home System program from 2014 in Off Grid areas. SNF is promoting solar Home System project in its working area. SNF has undertaken to promote different services under this project i.e. System installation, Loan support, Provide free post installation service, User training and different customer care. This project is likely to shut down its wagon wheel in the next fiscal years.

SNF Biogas Program has been implemented with the financial and technical assistance of IDCOL Bangladesh and SNF Sunlight Project with the own management of the SNF since 2014. The program's aim is to create friendly environment.

# **Case Study of Shefali Khatun**


Shefali Khatun (25) of Barail Polita under Magura Sadar, Magura. She was married with Abul Hague about 04 year's back. Since marriage, they were happily living in a peaceful family. Last year her husband's behavior began to change. He has demanding dowry and started torturing her physically and mentally. One day, she was tortured physically in such a way that one of her legs was broken. Shefali Khatun forced to return to her father's house. She with her broken legs returned to the helpless poor father's house was receiving treatment from the village's Kabiraj. There was no change her condition and had to go to the city doctor. Doctor told that her legs needed operation. She needed a lot of money to do so she continued to take the treatment through the village kabiraj. In her opinion, her husband does not get any inquiries. When Shefali Khatun tried to contact her husband, she went abusively in different languages and said she would get money from her father's house. Thus, many days are passing in her father's house. After that, she complained to the organization as SNF work on the legal Aid. According to the referral system of One Stop Crisis Center (OCC) rules based on the complaint, the victim has taken to the District Legal Aid Institute to provide medical aid and ensure Legal Aid. The Shishu Niloy Foundation (SNF) carried the whole travel expenses. On the basis of complaint from District Legal Aid Office, the notice was sent to the groom's party by the rules. Two parties were present on the scheduled day. In the meeting, the District Legal Aid settled the two parties through lawyers. As a result, the promise of her husband not to torture her again and thus it was closed. She again moved to her husband's house. Now her husband has started with treatment and she is very happy with her husband.





# **Case study of Rabeya Begum**

Mst. Rabeya Begum (23) is resident of Ichakhada (Utholi) of Ward No. 07 in hajrapur Union under Magura Sadar upazila is daughter of Md. Bazlur Mollah, Dinmujur and Morzina Begum, Housewife. She has two children. Husband Md. Moniruzzaman Monir Fakir, Son of Md. Omar Ali Fakir and Mst. Bhanu Bibi of Alipuri village. Moniruzzaman is the youngest one of the four. Rabeyar got married for six (06) years ago. Rabeya told that her husband did not do anything after marriage. His family depended upon with the left the property of his father and brothers to survive. He was addicted to gambling and intoxication. He often physically tortured Rabeya for gambling money and sent her to father's house. Her day labor father gave him money many times in the hope of supporting his daughter's family. At the time of her marriage, Rabeya's father gave many things for the happiness of her daughter. But Rabeya Begum's lavish and addicted husband continued to torture her physically and mentally by demanding money. Despite of torture Rabeya continued her husband's family. Two children were born her conjugal life. After the child's birth, her husband started torturing more. One day the neighbors rescued her in the abdomen torture and sent with her children to her father's house. Rabeya Begum came to know through the UP member that SNF is implementing DVPI project in this area. She managed to find out this sort of social problems and SNF were provided medical and legal aid to prevent family violence. Then she submitted a written complaint to the Shishu Niloy Foundation (SNF). Complaint was made to Magura Sadar police station for getting legal help against her husband through the organization. The process of prosecution is in progress. Now, like Rabeya Begum, if any women is victimized by own husband or a family, they can complaining to the Shishu Niloy Foundation (SNF) to get the proper solution.



# **Poverty alleviation and Economic Development through Microfinance & Financial Inclusion**

Financial empowerment is one of the important elements to address the sustainable development. Sustainable Development Goals (SDG), 'end poverty in all its forms everywhere' has fundamental role to achieve rest of the goals too. Now, it is proved that micro finance and financial inclusion program is an effective tool for poverty alleviation and empowering the poor in the world. SNF started its Microfinance (MF) program since 1999. Lack of access to the formal financial market deprives poor people in the facilities to save, borrow and invest in the productive business. The Formal Market including banking system also requires collateral why poor people can't access there. Financial Inclusion and services to the poor enable them to become engaged with different income generating activities, which in turn, allows them to become economically self-sufficient. It has gradually created a self-sustaining and reliable financial service program for the poor. Besides that, Micro finance program has helped the organization to continue its other social development activities with a sustainable grip. In 2005, with the aim to scale up the financial supports in different segments of the society in order to increase income earning sectors and making employment, SNF started its new era of micro-finance through making partnership with PKSF. Currently the organization has given efforts to digitalize the process by including financial services and green finance to end poverty in all aspects form anywhere. Collaboration with bank and other institutions has been enriching the program day by day.

# Goal

All the programs experimented for income generation using of modern technologies. It developed livestock extension workers and innovative service deliveries and also explored the use of matrix management systems for integrated development and created a development model for hard-to-reach areas.

Alleviating poverty and improving living standard of the common people through financial inclusion is the principle of SNF's mission and it has continuously been striving to achieve that goal since introducing microfinance program. Over the course of time, when SNF embraced microfinance program as its prime program, the process of financial inclusion has been getting stronger each year towards developing a society free from poverty. In addition, non-financial programs of the organization will be expanded to provide services to a large number people in the same period.

SNF savings program helping poor clients save bit for building better future.

For availing loans of SNF, whether it is small or entrepreneurship incumbents must be enrolled in certain savings schemes with the organization. Without enrollment in saving schemes, no one shall be allowed to receive loans from SNF. It is a mandatory obligation attached in loan program with a view to creating attitude and practice of saving money of the borrowers for meeting future economic need and tackling monetary crisis. It can be noted here that only loans can't serve the purposes of attaining self-retained status of the poor without developing a culture of saving money from the amount whatever they earn.

With an aim to facilitate the clients for reaping benefits from savings, SNF developed three Saving Products so that clients can save money relying on their financial capability.

The Savings Products are: 1) Regular Savings and 2) Long Term Savings (LTS). During 2018-19, SNF could successfully accumulate a substantial fund amounting to BDT. 431,368,057 as savings balance from its members.



# **JAGORON**

Shishu Niloy Foundation (SNF) is providing technical assistance and financial support only to the poor people whose age group member against on different small-scale farming and off-farming activities through Jagoron. The range of loan amount is BDT. 49,000 and depends on the nature of project.







Through minimizing the gaps in knowledge, awareness and accessibility to basic services, it is possible for a particular community to uplift in the mainstream development process. Besides that, external environment and natural disaster is a burning issue to be kept under consideration for a holistic sustainable community development.

For achieving desired level of development, sometimes SNF needs to carry out some activities in response to some special needs of the community. These interventions are needed base and incidental. SNF's Development Sector is comprised of Development Unit, Empowering its beneficiaries.

# ENRICH (Enhancing Resources and Increasing Capacities of Poor Households towards Elimination of their Poverty)

ENRICH is a program to develop the people through enhancing resource and capacities. This is an integrated development approach since 1st September'2014 at Alangi union of Kotchandpur Upzilla under Jhenaidah district.

The goal of the program is to ensure development of the whole community in all aspects. The project is addressing comprehensive approaches for development which includes healthcare, education, capacity building, formation of social capital, employment generation within the communities both in agro-based and non-agricultural enterprises, jobs for the youth, infrastructural development, Improved cooking stoves, solar home system, special savings program, special projects for the ultra-poor, disabled and elderly persons; beggars rehabilitation, demand-driven microcredit and community based programs etc.

The motto of this program is to encourage and facilitate the poor to take part in the development practices, as the main concern of this project is to ensure human dignity and liberty.

The ENRICH program focuses on overall household development through the best possible utilization and enhancement of their existing resources and capacities.

# **Objectives of ENRICH Program**



#### **Activities**

- Health service delivery including eye care and nutrition
- Education support;
- Sustainable income generating activities;
- Rural infrastructure development, construct culvert, bamboo and wooden bridges; etc.
- Install sanitary latrine, install tube well for institution
- Value chain development activities;
- Youth development activities;
- Job creation for rural youth;
- Establishment of SOMMRIDHO BARI (ENRICH House); and
- Beggars' rehabilitation.
- Social Advocacy and knowledge dissemination



# **Health Program**

The ENRICH Health Program is designed to provide comprehensive primary healthcare services for all households in the selected Union. Currently 10 health visitor and 02 health officer visit the households in the ENRICH Union. The health officer arrange satellite clinics every week which are attended by MBBS doctors. Health camps (vision, dental, heart, diabetes, etc) are also organized from time to time, with specialist doctors attending. In these camps, patients with serious ailments are referred to different public as well as private hospitals and clinics where their treatment is arranged free of cost. For the first time ever, ENRICH has also launched a de-worming campaign, giving away free medicine to 100% of its registered households for all members above 5 years of age.

# **Education Program**

The ENRICH Education Program primarily seeks to address the problem of drop-out of children from primary level education. Under this Program, at least one afternoon education support centre has been established in every village. All students up to Class II are helped in these teaching centers to prepare the next day's tasks, given that often there are no facilities and educational support for the students at their homes. Gradually, these centers will accommodate students up to Class V. These education centers take special care of students who are generally slow learners and need the extra help and time to grasp material taught at school.

# **Social Infrastructure Development**

SNF has been successfully implemented community-level social infrastructure development Program, the ENRICH promotes repairing or building culverts, bridges, sanitary latrines and shallow tube-wells in public places such as schools, colleges, madrashas, mosques, temples and libraries. Those facilities are using for good communication as well as healthy life of the selected union.

# **Sanitation Program**

The sanitation Program has been initiated under the ENRICH to ensure 100 percent safe sanitation throughout the ENRICH Union.

# **Homestead Vegetable Cultivation Program**

The Vegetable Cultivation Program encourages and helps small and marginal farmers in ENRICH Union to cultivate vegetables of various types in accordance with local cropping patterns and cropping seasons during the year.





# **Youth Development Program**

Youth development Program has been specially designed to help the youth to include human and social values and to generate employment opportunities for them. Efforts are made to create both self-employment and wage or salary based employment opportunities, and also to raise awareness against social ills (such as violence against women, dowry and drugs) and in favor of ethics, minority and fairness.

# **Beggar Rehabilitation Program**

The newest initiative of ENRICH is the Beggar Rehabilitation Program that targets the street beggars to transform them to become productive members of the society. A total of 04 beggars have been rehabilitated under ENRICH Program by giving 01 lac each.

# **Special Savings Program**

Saving is one of the methods of capital formation of the family. An asset base is important for a family to lift itself from poverty. Therefore, a special savings scheme has been designed under the ENRICH for the ultra-poor households. Female-headed households and families with disabled members are particularly eligible to join this scheme.

# **Special Financial Assistance Program**

Three types of special credit services have been designed for the ENRICH households: Income Generating Activities Loan (IGA), Livelihood Improvement Loan (LIL), and Asset Creation Loan (ACL). Under IGAL, eligible household members can take loan for more than one activity to increase their income.

# Life-style development program for the elderly People

About Improve Livelihood And Dignity Of Elderly People Aristotle said "Learning is an ornament in prosperity, a refuge in adversity, and a provision in old age."

Elderly refers to ages nearing or surpassing the life expectancy of human beings, and is thus the end of the human life cycle. This is a natural cycle of the human life and in the stage; people become very vulnerable in terms of physical and socio-economic condition. Every now and then the Elderly people are neglected in our community.

### **Background**

The organization started this program with the assistance of PKSF for the development of the lives of the neglected and destitute people of the society.

#### Goa

To improve the quality of life by bringing the old people into the social security net.

### **Objective of elderly people program**

Uplift the life status and dignity of the elderly people in our community



### The major activities



Under this program, 1570 senior citizens are involved. Among them 100 people were given a grant of BDT. 1,170,000 till June'2019 and 40 umbrellas, 40 walking Sticks, 04 wheelchairs, 100 blankets and 100 Chadors were distributed. Besides, 25 elders were distributed Crests and BDT. 90,000 was paid for the death among 45 senior citizens.



### **Adolescent Program**

Adolescents represent a major portion of total population in Bangladesh. But the existing social structure is yet unable to offer an adolescent friendly environment. The prevailing environment lacks adolescent-friendliness, confidentially that leads to social stigmatization and discrimination in the society. Consequently, different forms of barrier develop for the adolescent (boys and girls) in accessing accurate information and services. It is mentionable that the existing reproductive health services are generally inaccessible for the adolescents. SNF Adolescent club from the felt need of special emphasize on the issue of adolescent and their rights.

This intervention has been contributed in raising equality of access between different geographic and socioeconomic groups, and the gender gap has literally been removed at the primary level.

Following are the major conducted intervention during the reporting year:



### **Education Stipend**

In order to create opportunities for education of the children of the poorest members, PKSF has been promoting education activities since 2014. In the financial year of 2018-19, BDT. 1,416,000 was given as stipend among total 145 ultra-poor members'. This program will continue.

### **Social Advocacy and Knowledge Dissemination Unit**

Shishu Niloy Foundation (SNF) has been implementing various awareness programs through Social Advocacy and Knowledge Dissemination unit. 09 Clubs are active under the unit.

### **Key Features**

- Committee in the adolescent club consists of four members.
- Nutrition and social skills training was provided to the adolescents through the club.
- Nutrition Village has been established through clubs.
- In each village the villagers' has planted four types of nutritional plants such as papaya, amara, lemon and guava and sagna has planted at every house in the village.
- Blood grouping has been ensured of all the members of the community through the clubs.
- Diabetes examinations of the community have been confirmed through the clubs.
- The girls' members provide primary health care to pregnant women, especially weight; ensure nutrition through moke tapes, and blood pressure.
- Building awareness of the community about 1000 days of nutritious food list.
- Child marriage and dowry practice are prevented in the community through adolescent clubs, it is recommended to call 109 on the need basis.
- Meanwhile, early child marriage has been stopped, they are currently studying.
- Building awareness and suggestions are given by the hygiene sessions on what to do in the personal cleanness.
- Through the small community libraries which ensured in clubs, they are encouraged to study and there are about 20 different types of books.
- For entertainment there are chessboards, Ludu, football, etc.
- Club members arrange annual picnic for refreshers.

# A successful (papaya) vegetable farmer Shahidul Islam

Md. Shahidul Islam is a successful vegetable farmer in the village of Ganna Union of Kaliganj upazilla. He came from a middle class agricultural family. He is fifth number among his six brothers. He could not be educated in the family on account of his father's financial distress. His father became fairly experienced in cultivating vegetables to do agricultural work. In the 2010, his father separated all the boys from the family by giving them 66 decimal crop lands each. He started cultivating papava on his own land and leasehold another 105 decimal lands. Then in every year, the loan is taken from the organization and the land begins to grow in papaya with leasehold lands. He cultivated vegetables by turns, bought 06 acres of land, bought 01 lorry for transportation purpose of his own and leasehold worth about 25 lacs. He regularly employs 12 workers in his field. Every day a truck sends several vegetable to Dhaka for sale. He has goat firm of 25 goats. He desires to farm of cows in the future. In this way, he is making significant contributions to the development of society and the country by creating employment.



### Fish farmer Zahirul Islam

Md. Zahirul Islam is enlightened in fish farming in Harindia village of Balluhar union under Kotchandpur upazilla. He is the youngest of three brothers. Due to the financial constraints of his father, his studies could not be done too far. To assist his father financially, he helped his father in fishing. His father became fairly experienced in fishing.

Another positive direction achieved as he received youth development training from the Boluhar Fisheries Project. He started fisheries on his land for 5 years. He loaned from the organization to raise fish cultivation. In addition, he firmed 04 (four) cows at home. Regularly 10 to 12 workers work in his project. Each month, his net income is estimated to be 02-03 lacs excluding all expenses. With the money he buys land and continues to grow fish farming. In this way, he is on his way to contribute to the development of the local society.



### Salma Begum's rich life journey

Rangiarpota, a small village in Alangi union of Kotchadpur upazila under Jhenaidah district. Poor day laborer in this village Md. Momin Hossain's wife, Salma Begum with two children. There was no source of extra income for the family. In the meantime, she learned about ENRICH home under the ENRICH Program implemented by the Shishu Niloy Foundation (SNF), funded by PKSF, through the Enterprise development officer. She agreed to make ENRICH home. Later, SNF provided her with 15 fruit trees, 10 forest trees, 05 medicinal plants, various vegetable seeds, 01 friend's stove, 01 poultry house, 01 pigeon house, 01 vermin compost plant and flower plant and sex feromen trap as a home appliances. In addition to these things, She borrowed BDT. 50,000 from her own venture to raise income from the company and bought a cow, 03 goats, and 15 chicken and 08 duck. She planted a few papaya trees and vegetable beds, some of which have different types of vegetables on them,



By implementing these activities, the income of the family started to increase compared to the previous days. The income she gets from house and husband she is able to pay BDT. 1250 per week as the loan installments. A few months ago her only daughter married with a good circumstance. She is living a beautiful life at present.



# A successful Malta and guava farmer Salim Gazi

Md. Selim is a successful Malta and guava farmer of Karkadanga (Jolpara) village of Andul Bariya Union under Chuadanga district. He was born in a lower middle class agricultural family. He is the first of three brothers. He could not be educated in the family due to financing of his father. He used to assist his father in agricultural pursuits without having to study to help his father financially. When his father separated all the boys from the family by giving them 99 decimal of crop land. Selim started cultivating Malta and also Guava.



He receives loan from the SNF's Andulbaria branch. Currently cultivates huge malta and guava. He bought three cows in the house and 04 bighas of land in the field. He also sells good varieties of Malta and Guava plants and earns about BDT. 90,000 per month. In future, he intends to have a khurma palm garden. In this way, he is making significant contributions to the development of society and the country by creating employment.

### **Titon Hossain changed his fate**

Md. Titon Hossain is 38 years old, second of his 04 brothers. His father's name is Lutfar Jarda's and mother's name is Rashida Begum from a village called Bolabariya in Kotchandpur, Jhenaidah. After passing the HSC, Titon dreamed of cultivating small quantities of guava without paying any attention to studying. But due to lack of money, it was not possible to make his dream come true. He came to



the SNF's Alangi branch office and took out a loan of BDT. 50,000. With this money he cultivated Guava in 02 bighas of land. In the first year he benefited from the cultivation of guava. The following year, he borrowed BDT. 100,000 from the organization and continued his farming. Lastly, he took loan of BDT. 120,000 from the Alangi branch cultivated goavas on 04 bighas of land. Now he profits on average of BDT. 200,000 in each year. His social acceptance is increasing and a remarkable symbol to the youth society.



### The dreams came true of Vagirat Haldar

Vagirat Haldar, 45 years old is the eldest of his 03 brothers and sisters. He lives in Jagdishpur under Jhenaidah district. After passing the eighth grade he dreamt of cultivating small fish. But due to



lack of money, it was not possible to make his dream come true. He took BDT. 100,000 as a loan from the organization. With his own and loan money he leased 15 bigha ponds. In the second year, he took out a loan of BDT. 600,000 and leased 50 bighas. He is currently mixed fish farming with lease of 350 bighas and borrowed BDT. 1,000,000 from the organization. He has benefited from the fish farming. So far, he purchased 12 bighas of land from his own income of fish farming and has built a sixroom single roof beautiful house. He earns an average of 12 to 15 lacs taka per year.

### Rikta Khatun's success story

Rikta Khatun about 25 aged, husband's name Md. Manik Mia from Gurpara of Jhenaidah disrict. She got married after passing class eight.



Her family was living on low incomes. Then she made up her mind to do some work in addition. She took BDT. 40,000 one-time installment loan from the organization and carried with 01 cow fattening at the house level. Later, she got a loan of BDT. 60,000 and bought 03 cows and after six months later doing the fattening she sold all the cows at BDT. 230,000. At the 3rd stage she borrowed BDT. 100,000 and bought 08 cows. Now she is earning 12-15 thousand taka monthly on average and she made herself sufficient woman. Along with her husband's income their family is established now. They are passing happily married life with a three and half year old girl.

# Summer tomatoes cultivation Change the life of Shamsul

Shamsul Mondal, son of Shamsuddin Mondal, resident of Uazirpur village of Duliani union, Chougacha upazila under Jashore district. Shamsul Mondal is a farmer by profession. He has a family of four members with son, daughter and wife. He owns his 16 decimal own land in the field with his house and a lease for 02 bighas. He was unable to run the agricultural work. In the meanwhile, he learned through Agriculture officer of Shishu Niloy Foundation's Agricultural Unit and became a member of the organization. SNF gave various agricultural advice and exhibited different crops. Shamsul Mondal discussed various agricultural issues with the Agriculture Officer. He points out the reasons for his lack of profit in agriculture. Then Shamusul Mondal cultivate summer tomato





in 15 decimals of demonstration plot. He was given a grant of BDT. 15,000 to buy the seeds of tomatoes, make tunnels, cultivate the land, provide bed irrigation, etc. Shamsul Mondal is very good at cultivating summer tomatoes now and sells tomatoes worth about BDT. 90,000 this year. His future plans to plant summer tomatoes next year 01 bigha land. His demonstration has replicated to other farmers.

### **Iqbal's success in Guava plantation**

Md Iqbal Hossain, a successful farmer of Patibila village of Patibila union, has been successful in cultivating Thai-05 varieties of guava. From an early age, he had a tendency towards agricultural work. His passion for cultivating of new crops. Md. Iqbal Hossain showed interest in cultivating guavas since the spring of this hobby. Following the interest of Md. Iqbal Hossain, the he took two-day training under the KGF, funded by the PKSF and started cultivating the guavas as a new method. A total of BDT. 5,000 are provided for the plants, sign boards, etc. The trees



grew refreshed and beautiful; doing everything he could to cultivate the plants. The tree began to bear fruits. After many attempts, the fruit was finally sold to the local market. He has been selling guavas from his garden for BDT. 70,000. Farmer Md. Iqbal Hossain assured that Thai-05 varieties guava are very deliciously sweet juicy and safe and now he is planning to plant new ones in a bigha land whose courage and inspiration has been given by the Agriculture unit of the organization.

### **Vegetable farming in the pond side success**

Mohammad Morshed Ali is a successful fish and vegetable farmer in Maheshpur upazila of Jhenaidah district. He started farming fish in a pond of 40 decimal with lease hold. He is one of the respected members of the organization. Morshed Ali was inspired and motivated by the Fisheries and Livestock Unit, implemented by SNF. He used to plant only a few banana trees on his pond side. Later on hearing from the fisheries officials he started planted eggplant saplings, tomato seedlings, shrubs, sweet pumpkin and lawn seeds two sides of the pond.



These seedlings and seeds are supplied from the office and he himself also plants some seedlings. Later, he was given technical training for skill development in fish farming and vegetable farming for two days. After training, he became more active towards pond fish farming and vegetable farming. Currently, Morshed Ali is selling a lot of vegetables from the pond. Last season, the total cost of cultivating his pond was BDT. 40,700 and total profit was BDT. 32,200 from the vegetable. He could not imagine that there would be so much benefit in cultivating vegetables on the pond sides. Besides, he has benefited BDT. 44,000 last season by farming fish. Morshed Ali expressed his appreciation to the organization's fisheries and livestock unit and said that "such activities play a role in improving the quality of life of poor people."

# Shahanara Begum's success in farming with Vietnam-Koi fish

Shahanara Begum, a member of the organization and a simple housewife in Chougacha upazila under Jashore district. She started with BDT, 30,000 loan money and now she owes BDT. 70,000. Shahanara Begum was inspired and encouraged by the SNF's Fisheries and Livestock Unit. Later, her husband Shamsul of Janata male somity was given two days' skill development workmanship training and a grant of BDT. 7,000. The grants include fish pans, fertilizers, apricots, vermin compost, vegetable seeds, papaya seedlings and lime and rotten powder. Currently, Shahanara Begum is selling a lot of vegetables from the pond. In the first season (6 months) after receiving the refinement, she sold BDT. 21,000 vegetables and BDT. 40,000 fish. At present, she lives with her family in greater happiness and peace than before.



### A poor ornament-maker owns a factory

Imran Hossain, now at his 29, was a poor imitation-maker of Maheshpur under Jhenaidah. His aging father, also an imitation-maker, became unemployed due to illness. Hence, Imran had to take all responsibilities of the six-member family.

With a scanty capital, Imran crafted cheap earring with the mixed metal of bronze, brass and copper. He used impermanent Dry Golden to color the imitation items. "Coloring 100 pieces of earring would cost Tk100 then," Imran said.

In 2016, Imran got in touch with the Shishu Niloy Foundation. He took part in training sessions and learnt imitation crafting with automated machines.



Now, he can craft all types of traditional jewelries such as bangles, check neck less, earring and finger ring. He uses expensive Golden Print color to make the ornaments longer-lasting."Coloring 100 pieces of ornament now costs BDT. 2,000. The value-addition facilitates me in attracting more buyers," Imran told The Business Standard.

Previously, Imran could sell the cheap products merely at village fairs. Now, his products gain a market in 35 district headquarters, including Dhaka, and enthusiastically online.

"Three years ago, my daily earning was around BDT. 150. Now his daily earning surpasses BDT. 400. he has employed eight workers at my cottage-based factory," Imran said.

Masud Karim, a Shishu Niloy Foundation's staff overseeing the value chain under the PACE project, said organization will be sponsored Imran in coming October'2019 this year to visit India to observe jewelry industries in Gujrat, Rajkot and Kolkata.

"Expensive machineries will be needed to craft the Indian-standard imitation jewelry. But he is experienced and enthusiastic about it," Imran said.

The financial statements are prepared following international accounting standards. SNF is concern to ensure the area of financial reporting, accounting records and source documentation, internal control, budgetary control, fund management and compliance.

SNF has developed detailed financial and procurement policy comprise with rules and regulations on account management. A specific budget is maintained for each project at SNF. The head office compiles the individual project budgets to develop the organizational annual budget in each financial year.



### **Achievement**

- Financial planning, record-keeping, and managing costs, assets and liabilities;
- Financial investments, analyzing cash-flow, profitability, prepares budgets and financial frameworks for programs
- Effective financial control and transparency of the financial data of running projects and programs garnering trust and confidence from all those with whom we work.



### **Monitoring and Evaluation**

As a part of SNF's internal control mechanism, the monitoring and evaluation provides support to SNF's core programs and projects. It delivers information for decision making at policy and operational levels. The monitoring and evaluation conducts periodic analysis based on set standards to ensure transparency. It assists the management to determine whether key activities are being carried out as planned or they are not achieving the expected outcomes. SNF's most of the programs are designed to contribute in achieving the MDGs and SDGs. Continuous feedback on program performance ensures smooth operation and progress towards achieving these development goals.

In 2018-2019, the monitoring and evaluation conducted monitoring on field level and management level issues and delivered 08 monitoring reports covering all core programs, projects and supporting departments. The reports are produced based on the monitoring findings. The shared findings facilitated quick remedial measures for the respective programs.

### **Internal Audit**

The internal audit department is an independent unit within SNF which aims to maintain transparency and accountability across the organization, directly reporting to the Executive Director.

The department's auditors independently examine and evaluate all activities covered at branch level to suggest management on operational efficiency. It also assesses the effectiveness of SNF's management control, governance and risk management services. The department's services include routine system and special audits, investigations and annual inventory verification. In the reporting year, the internal audit team has conducted 68 audit visits and submitted report to Executive Director.

Three major accomplishments of SNF internal audit team

- Assess the efficiency and effectiveness of internal control system
- Rationalize implementation strategy in line with organizational policies and systems
- Verify accounting records and relevant information.

### **Management Information System (MIS)**

SNF has been combined with fully integrated management information system application software through full equipped data Centre i.e. servers, storages, etc. At present, employers have been able to serve clients more efficiently with the support of these technologies by reducing paper work. Technology uses have increased accessibility to information and simplified computations of complex analyses.

Financial Information Systems (FIS) has been using to access or analyze financial information more efficiently for better decision-making, cost budgeting and cost Centre management, report generation and database query/ analysis capacity. All the branches of SNF are brought to full automation coverage already which is connected with the head office.



### **Procurement & Regulatory Compliances**

A procurement committee is playing proactive roles to manage the requisitions of purchase for the program. Throughout the entire process it follows the procurement guidelines and implementation procedures of SNF which are transparent and developed in line with international procurement standard.

### **Reporting and Publication**

SNF has an efficient reporting and publication unit which prepare many kinds of organizational reports both for internal and external uses. All sorts of publication are published from this unit, too like by-yearly SNF-Darpon, Annual Report, program specific brochures etc. are the regular outputs of this unit.

### **External Audit**

The SNF general body appointed chartered accountants farm for audit completion. They duly conducted the audit and signed the audit report. Auditors report and the audited financial statements have to submit to the different GO- NGOs bodies as required. The audit reports of the reporting year are enclosed at the end of the annual report. During the mutually agreed timeframe of annual audit, the auditors have access to all books, records, vouchers, minutes and other documentation as per their requirements to conduct the audit effectively.


